Based on the reply furnished by the college/institute, approval of the PGMEB is hereby accorded in terms of Section 25(i) and 35(4) of NMC Act, 2019, for grant of **Renewal of Recognition of MD(Forensic Medicine) qualification for 03 seats in respect of students being trained at M. S. Ramaiah Medical College, Bangalore under M. S. Ramaiah University of Applied Sciences, Bangalore**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.
