### 5.1.2 Capability enhancement and development schemes employed by the Institution for students:

1. HEI has noted the observation made by DVV.
2. All these activities are clubbed under seven capability enhancement schemes.
3. HEI being the Health Sciences college have considerable amount of these components of skills and capability enhancement through competency-based curriculum.
4. As a college with professional medical programs, the AETCOM module (Attitude, Ethics, Communication Skills) is a part of the curriculum. The SOP for Health Science manual does not distinguish between the capability enhancement and skill development programs either within the curriculum or over and above the curriculum.
5. None of these seven capability enhancement schemes claimed are part of undergraduate and post graduate curriculum and therefore is eligible as per NAAC SOP.
4. The awareness and requirements of Geo-tag photos is only recent requirement of last 1 or 2 years. Earlier years this concept was not in practice, nor it was mentioned in the SOP of the manual. Hence the earlier reports are submitted with the available photographs duly certified by Principal and Dean.
5. DVV to kindly consider the HEI input of the same.

The HEI has given the data for Metric Id 5.1.2. The data is resubmitted with claims and supporting documents for the kind perusal by the DVV. They are as follows:
