Cars parked on pedestrian path do not support the HEI claim of restricted entry of automobiles. The HEI links are not operational. The HEI has not attached photographs showing Greenery on campus and water management system. The HEI has input only values in a table without supporting document. The HEI has not provided audited income/expenditure sheets. Mere statement of number without supporting proof cannot be evaluated. The HEI to provide annual audited statement of income an expenditure, duly certified by

- 1. The HEI is providing its green campus policy document, numbered, dated and signed by the head of the institute.

The HEI must provide its green campus policy document, numbered, dated and signed by the head of the institute.HEI to provide Geo tagged photography /Videos of the facilities such as battery powered vehicles, use of bicycles etc, captioned and signed by the principal. HEI to attach circulars, with ref and date for the pedestrian friendly path ways, ban on the use of plastics, vehicular traffic and restricted entry of automobiles.

- 4. An **audit on use of plastics** in the campus was conducted. The geotagged photos with captions and the report is being submitted for kind consideration.
- 5. Extensive varieties of plants and trees are available throughout the campus and is very well maintained on daily basis. The HEI has now attached photographs and Video showing Greenery on campus.
- 6. The HEI has is providing audited income/expenditure sheets certified by the charted accountant and countersigned by the principal excluding the salary component for the assessment period FY 15-20. The HEI has outsourced the housekeeping to SS enterprises and is enclosing the document for consideration.
- 7. HEI is attaching the circulars, with ref and date for the pedestrian friendly path ways, ban on the use of plastics, vehicular traffic and restricted entry of automobiles.
