Sir/ Madam,

I am directed to state that the Postgraduate Medical Education Committee of this Council at its meeting held on 29.05.2018 considered the Compliance verification Report (04.05.2018) and Council Assessor's Report(s) (July, 2017) on the standard of examination and other teaching facilities available for Renewal of recognition of M.Ch.(Plastic Surgery) qualification for 01 seat at M S Ramaiah Medical College, Bangalore granted by Rajiv Gandhi University of Health Sciences, Bangalore. The Committee decided as under:-

The Postgraduate Medical Education Committee considered the Compliance verification Report (04.05.2018) and Council Assessor's Report(s) (July, 2017) and decided to recommend to the Central Government that the recognition M.Ch.(Plastic Surgery) qualification for 01 seat granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at M S Ramaiah Medical College, Bangalore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

The above minutes of the Postgraduate Medical Education Committee have been approved by the Oversight Committee vide their letter dated 12.06.2018.

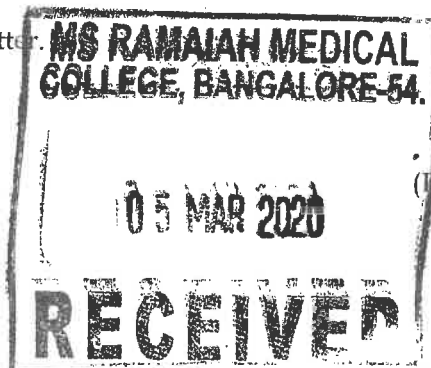
Sir/Madam,
