The HEI is to provide a certificate signed by the Principal that these qualifications have not been claimed in 2.4.2. The following have NOT been considered. #### **Response of HEI:**

- The HEI has noted the observations given by DVV.
- The minimum qualification as per NMC/MCI guidelines for faculty appointment is MD/MS/DNB for broad specialties
- The minimum qualification as per NMC/MCI guidelines for faculty appointment is MCh/DM/DNB for super specialties.
- The HEI has claimed only those faculty who have MD/MS/MCh/DM as minimum qualifications for faculty appointment and DNB is an addition to minimum qualification.
- Faculty with only DNB as minimum qualification has not been considered.
- For Eg: Dr Babitha Rajan has DNB degree in addition to MD in Community Medicine, hence she is considered for additional degree of DNB. Whereas Dr Vijayashree has only DNB General Medicine as minimum qualification hence not considered for 813.
- The PGDMLE, PhD in Physiology are all additional degrees offered by prestigious universities and institutions like National Law School University, Bengaluru and Rajiv Gandhi University and Health Sciences. Hence request the DVV to consider the same.
- Postgraduate Diploma in Hospital and Health Management and PG Diploma in Geriatric Medicine are diplomas offered by IGNOU under the Government of India. Hence request the DVV to consider the same for calculation.
- Diplomate of American Board of Pediatric Hematology also to be considered as NAAC manual has expressed AB as an example for additional degree.
- Master's in Business Administration also to be considered by DVV as an additional degree.
- The HEI has not claimed any faculty with minimum qualifications as prescribed by MCI/NMC for the metric 813.
- Taking into consideration the inputs of DVV, the reconciled data is being submitted for consideration by DVV
