- Since, the MCC is not aware of the number of Recognized/ Permitted seats for each college and allotment is made purely on the basis of merit, it is on the discretion of College/ Institute to provide Recognized/ Permitted Seats to the Allotted candidate as per their policy /rules and regulations. However, as a general rule, the candidate with higher merit/ NEET SS rank may be preferred for recognized seat followed by next candidate for permitted seat.
- Colleges/ Institutes where there have been increase of seats by NMC can contribute the additional seats/ increase in seats for Round-2 on the portal. It may be noted that colleges should not contribute the seats remaining vacant/ resigned after Round-1 or those which have already been contributed in Round-1, as such seats are in system and will be included in seat matrix for Round-2 automatically by the software. Contributing such vacant seats of Round-1 will lead to duplication of seats in the matrix.
